

### **Scotton Parish update for 2024 to 2025**

We started the new year with a new dedicated website, new .gov domain name for the Parish and also for the Councillors. This making Scotton Parish Council up to date with recommended good practice and will soon be legislation.

We also had our first Summer Fair which incorporated a garden, allotment and other categories competitions. This was very successful and we are building on this for our next one which is due in July 2025

We purchased a new laptop and smart tank printer which has enabled us to print out our own newsletters in a cost effective way, they were delivered in November.

Our internal auditor recommended us to find a proper accounting system and through recommendations we opted in to Scribe which has proven to be very successful and will help with the budgeting forecasts.

We had another successful Christmas Dinner which was sponsored by Cllr Tom Jones.

We have removed 3 Ash trees which have been causing problems as they had ash die back.

Hawthorne play park has seen a big update which was helped with an awards for all £20k award. We removed the tired equipment and put new swings, zip wire, activity frame, goal/rugby posts, basketball posts and muga repaired. This has been a huge success and lots of children and adults are now using this. We have also been consulting on Meanee play park which is currently closed as needs repairs doing to it. We would like to change the use of the park into a garden which will be less costly to maintain and more beneficial to the residents. As a Parish we are aware that lots of the play equipment is nearing its end of life so we have an account for this and precept money into the account.

We have given the go ahead for the fencing on Hawthorne park, both sides of the allotments fence to be replaced which is due to commence in June.

We have given grants of £500 to the Citizen advice and CRAGGL as lots of the residents who reside in Scotton use them.
