MINUTES FOR THE MONTHLY MEETING OF SCOTTON PARISH COUNCIL held on Monday the 7th of July 2025 in Scotton Village Hall at 7pm

- 59. To Receive apologies for absence Cllr Kitching, Cllr Greensmith
 - 59.1 To receive and consider for approval, reasons given by councillors for their absence approved
- 60. To receive Councillors declarations of interest none recieved
- 61. <u>To consider updates from County Councillor to move till after the oprocal of minutes</u> none recieved
- 62. <u>Approval of minutes of Scotton Parish Councils Monthly meeting held on 02-06-</u> **2025** – Proposed Cllr Bennett and Seconded Cllr Fulton
- 63. <u>To receive and consider questions from the public –</u> Clerk updated the Cllrs regarding emails that have been sent regarding the fence and overgrown hedge that backs onto the allotment path. **RESOLVED** to look at this in the outdoors meeting. Email was received regarding a fence on Kestrel Drive and the clerk has asked them to write or contact planning.

PROPOSAL: Outline planning permission with all matters reserved for construction of 4no. 2 bedroom dwellings, 4no. 3 bedroom dwellings and 2no. 4 bedroom dwellings and tree planting LOCATION: Land To South And West Of Willowgarth Ringwood Road Scotton Catterick Garrison APPLICANT: Mr L Parker ZD25/00171/OUT

Discussions with the members of the public and Cllrs took place regarding this application and it was **RESOLVED** to object to the planning application and for the clerk to send a copy of the objections to the Cllr before sending to the planning.

Highways have raised concerns and recommended refusal, Ringwood Road is unadopted and is not a safe road. Agriculture occupancy restrictions on the land. Flooding has happened on this road and a soak away is insufficient. Bungalow was flooded a couple of years ago. The ecology report was a desk top survey and no mention of the badger set, hedgehops and numerous species of birds that have their habitat, in this natural place of beauty. A speculative

development and not in line with the former district local plan and with the core councils plan. Lots of other brown field sites that could be developed on. The lane was originally designed as an access route for the 18th century properties in Old Scotton and not designed for modern traffic. Transport and connectivity are virtually non-existent

Clerk reminded about policy consultation which will take place on the 9th of July and NYC Schedule of changes and an event in Harrogate to raise awareness of Martyn's Law. She updated the Clirs on the .gov emails and why they need to be used.

- <u>69.1 To discuss and consider bank recs May and June 2025 bank statements</u> Cllr Fulton had checked the bank statement against the payments and receipts invoices and proposed that they were accurate, seconded by Cllr Whitehead.
- <u>69.2 To discuss and consider BACS for approval</u> Clerk advised the Cllrs that she will need transfer up to £12k from the savings account and it was **RESOLVED** to only transfer what is needed when it is needed and the BACS for approved.
- <u>69.3 To discuss and consider quotes for post renewal in allotment</u> Discussions took place it was **RESOLVED** to get another quote as the post which was put in free did not do the job.
- 69.4 To discuss and consider the fixing or replacement of a noticeboard Discussions took place regarding purchasing new noticeboard and the fixing of the old one. It was **RESOLVED** to move with the first quote of £523.60 but to add the sleeves as this would fit in with our biodiversity policy upcycling the oak noticeboard.

It was **RESOLVED** to look at the quotes for the removal of the dead Ash trees in Oak tree park as it was discussed at agenda item 53. 4 last month. It was **RESOLVED** to accept the first quote of £600 but for the waste to be removed. One of the tree surgeons had noticed some elm trees that looked dead, clerk to let highways know.

Scotton Parish Council discussed the Boundary review at their last Council Meeting which took place on Monday the 2nd of June and this is their response.

Scotton Parish Council (Catterick Garrison) do not agree with the proposal from the Boundary Review and would like to remain within Richmond District.

The last Boundary review separated Scotton from Catterick Garrison, which is where Scotton feel is best fit.

Additionally, we determined that the Liberal Democrats' proposed Swale division provides for a more appropriate balance of the statutory criteria than the Council's Swale division. This is because, by bringing together parishes along the River Swale – from Catterick to Morton-on-Swale – into a single division, the Liberal Democrats' proposal more effectively reflects local community identities and interests. This proposal for the Swale division does not fit with Scotton!

Scotton are not near to the Swale and do not have any connections with Morton on Swale and other rural communities.

Scotton is very much part of Catterick Garrison using the local schools and health provision.

Scotton has a large proportion of military in its Parish, including the largest military infantry training centre in Europe and Somme Barracks

Scotton Parish consists of a large amount of ex-service personnel including a large Nepalese and Fijian community who are very much part of Catterick Garrison and have no identities or interests with the rural areas.

Scotton has no community connection or interests with small villages which are over 20 miles away

Scotton needs to remain within the Garrison where it has connections with the new Town Centre and other camps, for example Munster Barracks

Scotton and Catterick Village have the largest electoral voters but Catterick Village is a village in its entirety. Scotton has always been very much part of the Garrison and starts from the original Scotton which is situated on the outskirts right to what is called Camp Centre. The last Boundary review split Scotton from Catterick Garrison much to the disappointment of its community, to Scotton and Lower Wensleydale.

This Boundary review proposal would completely move Scotton from Richmond, Colburn and move them to Thirsk and Northallerton area, again no community, identities or interests.

Scotton would welcome anyone to come and visit its Boundary so they can fully appreciate that Scotton needs to remain within Catterick Garrison
