143.4 – To discuss and consider cost for Village Hall valuation – Clerk still waiting for cost from the insurance company.

143.5 – To approve payment by petty cash, donations and BACS for the Christmas Lunch – Payments were approved Cllr Paley and Cllr Greensmith. Discussions took place regarding the success of the Christmas Lunch.

143.6 – update on Co-op bank account – Discussions took place regarding accessing the Co-op account, which is proving to be difficult. FSCS has increased to £120K. **RESOLVED** to check if HSBC bank has increased to £120K HSBC and to check the mandates.
